

REGULAR MONTHLY MEETING OF COMMISSIONERS ROADS & REVENUE HELD TUESDAY, JULY 2nd, 1940.

Present:- R. A. Gould, W. McD. Harley, R. L. Ratcliffe, V. H. Royal, C. V. Abbott and J. B. D. Paulk.

Minutes previous meeting read and approved.

The following reports were approved and ordered filed:-

Moved by Commissioner Abbott, seconded by Commissioner Harley, to approve all disbursements for the period June 4th to July 2nd, 1940 inclusive in the total amount of \$34,031.06 covered by Vouchers #56228-56424 inclusive. Unanimously adopted.

A committee consisting of Messrs. Ringel, Bates, O'Quinn and Thiott, representing the Young Mens' Club, appeared and requested an appropriation of \$250.00 for traveling expenses of representatives making necessary trips in connection with proposed civic improvements and new industries. Moved by Commissioner Royal, seconded by Commissioner Harley, that the Board of Trade be requested to handle necessary expenses in connection with such trips, the authorization and details to be coordinated through the Board of Trade. Unanimously adopted.

Moved by Commissioner Harley, seconded by Commissioner Abbott, to guarantee completion of condemnation proceedings by Glynn County and payment of awards of same into court in connection with securing of Right of Way on Project 355-C (1) Glynn. Unanimously adopted.

Moved by Commissioner Royal, seconded by Commissioner Abbott, to approve the "List of Errors and Defaulters Relieved" prepared by J. M. Exley, Tax Commissioner, under date of June 30, 1940 consisting of five (5) sheets, totalling \$281.49. Unanimously adopted.

Moved by Commissioner Abbott, seconded by Commissioner Ratcliffe, to authorize the necessary legal procedure to remove encroachments on rights of way on Railroad Avenue on St. Simons Island in order that W. P. A. paving project may be secured. Unanimously adopted.

Moved by Commissioner Harley, seconded by Commissioner Royal, to authorize payment of salaries to all County Employees for period that they are in military training. Unanimously adopted.

Moved by Commissioner Royal, seconded by Commissioner Ratcliffe, to authorize the Clerk to write the Waynesville Naval Stores, the Riley Estate and Harrington Estate requesting that they furnish the necessary timber for the construction of bridges through their property in connection with construction of CCC truck trail #12020 which begins at the intersection of State Route #40 at a point one mile west of SAL Railroad crossing and extends north to the Waynesville road. Unanimously adopted.

Moved by Commissioner Abbott, seconded by Commissioner Harley, to authorize H. J. Friedman, Engineer-Director, to make trip to San Francisco to attend the National Planning Conference to be held July 8th-10th. Unanimously adopted.


