

REGULAR MONTHLY MEETING OF COMMISSIONERS ROADS & REVENUE, HELD THURSDAY, NOVEMBER 7TH., 1940.

Present:- R. A. Gould, W. McD. Harley, C. V. Abbott, V. H. Royal, J. L. Owens, J. B. D. Paulk, and R. L. Ratcliffe.

Minutes previous meeting read and approved.

Moved by Commissioner Abbott, seconded by Commissioner Royal, to approve all expenditures for disbursement for the period October 4th., through November 6th., 1940 inclusive in the total amount of \$18,918.40, covered by Vouchers No.56979-57139 inclusive. Unanimously adopted.

Moved by Commissioner Royal, seconded by Commissioner Abbott, to authorize the Chairman and Engineer-Director to arrange for the appointment of a successor to Doctor A. N. Galin, who is leaving the County to go into Military Service, with the understanding that, in line with the policy of the County, the appointment is a temporary one, Doctor Galin to be reappointed at the expiration of his military service; successor to be paid the same salary as Doctor Galin, or \$75.00 per month. Unanimously adopted.

Moved by Commissioner Ratcliffe, seconded by Commissioner Owens, to approve "List of Errors & Defaulters Relieved" submitted by Tax Commissioner J. M. Exley under date of October 31, 1940 and consisting of five sheets, totalling \$1,075.94. Unanimously adopted.

Moved by Commissioner Royal, seconded by Commissioner Abbott, to authorize adjustment of the 1940 taxes of the R. T. Crane Estate on the basis of the proposed 1941 assessment, which the Board of Tax Assessors had under discussion, in line with letter of November 1, 1940 from Reese, Scarlett, Bennet & Gilbert. Unanimously adopted.

Moved by Commissioner Abbott, seconded by Commissioner Ratcliffe, to authorize appropriation of \$15.00 to the Herty Forest Institute and extend to the organization the approval of Glynn County in the work that they are doing. Voting Aye: Commissioners Ratcliffe, Paulk, Abbott and Gould. Voting Nay:- Commissioners Royal, Owens and Harley.
