OFFICIAL GENERAL ELECTION BALLOT OF THE STATE OF GEORGIA NOVEMBER 8, 2016

To vote, blacken the Oval (●) next to the candidate of your choice. To vote for a person whose name is not on the ballot, manually WRITE his or her name in the write-in section and blacken the Oval (●) next to the write-in section. If you desire to vote YES or NO for a PROPOSED QUESTION, blacken the corresponding Oval (●). Use only blue or black pen or pencil.

Do not vote for more candidates than the number allowed for each specific office. Do not cross out or erase. If you erase or make other marks on the ballot or tear the ballot, your vote may not count.

If you change your mind or make a mistake, you may return the ballot by writing "Spoiled" across the face of the ballot and return envelope. You may then mail the spoiled ballot back to your county board of registrars, and you will be issued another official absentee ballot. Alternatively, you may surrender the ballot to the poll manager of an early voting site within your county or the precinct to which you are assigned. You will then be permitted to vote a regular ballot.

"I understand that the offer or acceptance of money or any other object of value to vote for any particular candidate, list of candidates, issue, or list of issues included in this election constitutes an act of voter fraud and is a felony under Georgia law." [OCGA 21-2-285(h) and 21-2-383(a)]

Glynn County Special Election Special One Percent Sales and Use Tax
(Vote for One)

Shall a special 1 percent sales and use tax be imposed in the special district of Glynn County for a period of time not to exceed fourteen calendar quarters and for the raising of an estimated amount of \$71,595,000 for the purpose of funding the acquisition, construction, and equipping of the following capital outlay projects: (i) road paving, resurfacing, reconstruction, extension, and widening for Glynn County; intersection and traffic flow improvements for Glynn County; road and public parking lot resurfacing for Jekyll Island; street milling, paving, and other road infrastructure improvements, including wayfinding and gateways, for the City of Brunswick; (ii) drainage and storm water improvements for the City of Brunswick and Glynn County, including bridge construction for Glynn County; (iii) sidewalks for Glynn County; sidewalks and trails for the City of Brunswick; (iv) improvements to sewer systems in the City of Brunswick and Glynn County; (v) public safety radios and police and fire vehicles for the City of Brunswick; and (vi) veterans' memorial and courthouse parking improvements for Glynn County and renovation, restoration, rehabilitation, and improvement of public buildings, facilities, and property for the City of Brunswick, including Fire Station 1, Senior Center, and parks, squares, and cemetery in the City of Brunswick.
