If you make a mistake or change your mind on a selection:

- A.** Do not attempt to mark through the selection or attempt to erase. Write "Spoiled" across the ballot and across the return envelope
- B.** Mail or return the spoiled ballot and envelope to your county board of registrars; a new official absentee ballot will be mailed to you

If you decide to vote in-person: Surrender the ballot to the poll manager of an early voting site within your county or the precinct to which you are assigned. You will then be permitted to vote a regular ballot

Neal Jump (Incumbent) Republican</p> <p><input type="radio"/></p> <p>Write-in</p>	<p align="center">PROPOSED CONSTITUTIONAL AMENDMENTS</p>	<p>1 % Sales Tax for Educational Purposes (Vote for One)</p> <p>Shall a one percent sales and use tax for educational purposes be imposed in the Glynn County School District for a period of time not to exceed 20 consecutive calendar quarters in order to raise not more than \$112,000,000 for the purpose of acquiring, constructing, and equipping the following capital outlay projects: (a) a new Glyndale Elementary School, (b) additions, renovations and modernization at St. Simons Elementary School, (c) renovations and modifications at Golden Isles Elementary School, Oglethorpe Point Elementary School, Satilla Marsh Elementary School, Greer Elementary School, Goodyear Elementary School, Needwood Middle School, Sterling Elementary School, Jane Macon Middle School, Glynn Middle School, Risley Middle School, Glynn Academy, and Brunswick High School, (d) kitchen expansion and renovations at Golden Isles College and Career Academy, (e) school buses, (f) road work, including the extension of paved parking at the Transportation Facility and improvements at Brunswick High School, (g) improvements at athletic facilities, including sports turf and lighting at Brunswick High School and Glynn Academy practice athletic fields and tennis courts at Brunswick High School, and (h) other real and personal property for the school system, including sidewalks and covered walkways, any necessary demolition, site improvements, renovations, and improvements to facilities, land acquisition, technology upgrades, computers and related technology including fiber and software, telephone and communication equipment, computerized energy management systems, heating and air conditioning systems, lighting, and similar property and equipment in accordance with its facilities plans, as the same may be revised in accordance with the needs of the School District?
