HOW DO THE NEW VOTING LAWS IMPACT ME?

Can I still Absentee vote?

Yes! Georgia still offers no-excuse absentee voting. You will need to include either a Georgia Driver's License or ID number, your Social Security Number, or a copy of any government issued photo ID, with your application and ballot. Ballots can be requested up to 79 days in advance, until 11 days before an election. Family members, caregivers, sworn assistants, elections officials, and Postal employees will be the only people allowed to deliver your ballot.

What about drop boxes?

Glynn County will have only one drop box during elections, located inside the Board of Elections office. It is under constant video surveillance and is only accessible when elections officials are present. Unfortunately, our number of registered voters do not qualify us for additional drop boxes at Early Voting locations. Drop boxes will only be open during Early Voting hours, after hours drop offs will no longer be available.

Is Early Voting still available?

Yes! In fact, now you have two Saturdays of early voting. You may still vote at any of the three locations. Glynn County has never held Sunday voting, but if turnout and population growth ever demanded it, the option is available.

I always vote on Election Day, does this law impact me?

You may notice some changes. Glynn County has always deployed the maximum amount of machines for state and federal elections, but this is now guaranteed by law. If you previously voted provisionally out of your precinct, you will not be allowed to do so until after 5pm with an affidavit that you cannot get to your regular precinct. Voters can be more easily challenged, but you will have more time to be notified and respond before action is taken. There are new rules about filling vacancies, ensuring your November ballot will be simpler and easier to make your selections.

Why can't I bring water to voters?

It has always been unlawful to give voters or poll workers anything which could be perceived as a reward for voting.

How does this law secure my vote?

This law increases transparency. Totals of counted and outstanding ballots will be made public throughout the voting period. Equipment testing and ballot tabulation will be more visibly advertised. Ballot images will be public records available from the State, though ballots will remain anonymous. Glynn County has always enlisted representatives from both parties to monitor and judge ballot tabulation, but this is now a statewide law. There are also now harsh penalties for Elections offices which violate these laws.
