- (3) Calendar call will be held on **August 9, 2021 at 9:30 a.m.**, per the attached calendar.
- (4) Motions will be heard on **August 13, 2021 at 9:30 a.m.**
- (5) Jury selection will commence on **August 23, 2021 at 9:30 a.m.**
- (6) Trial will commence on **August 25, 2021 at 9:00 a.m. and shall continue through September 3, 2021.**

It is further **ORDERED** that jury selection shall take place at the designated courthouse annex building, Selden Park Gymnasium located at 100 Genoa Drive, Brunswick, Glynn County, Georgia; and jury trials shall take place in Courtroom 1 at the Glynn County Courthouse, Brunswick, Georgia.


It is further **ORDERED** that negotiated pleas will not be accepted by the Court after calendar call on August 9, 2021.
