### **2021 Update 1- COVID-Delta Variant – Glynn County Closes Offices to the Public**

Due to recent Coronavirus outbreaks, Glynn County will close buildings to the public beginning on Monday, August 16, 2020. The Special Called Commission Meeting on Tuesday, August 17, 2021, and the Regular Commission Meeting on Thursday, August 19, 2021, will continue in person due to scheduled public hearings. The Island Planning Commission meeting on Tuesday August 17, 2021 will also continue in person as scheduled. Masks and temperature checks will be required to attend the meetings Future meetings will return to a virtual format.
