FAQ

How did SPLOST come to be?

The Special Purpose Local Option Sales Tax (SPLOST) law was enacted in 1985 at the request of the ACCG. The SPLOST was conceived and enacted as a county tax for funding capital projects.

Who pays SPLOST?

Everyone who makes a purchase within Glynn County will have the 1% sales tax on their purchase. Based on historical data, it is estimated that as much as 44% of the SPLOST will be paid by the numerous visitors and tourists who travel through or stay in Glynn County annually.

How was the SPLOST list created?

The Glynn County Board of Commissioners created this list following community listening sessions, town hall meetings, consultant advisory meetings, financial analysis, and examining feedback from the Community Sentiment Survey.

When will this referendum be voted on?

The SPLOST 22 referendum will be placed on the November 8th General Election ballot.
