- (1) Both parties shall exchange discovery no later than **October 31, 2022**.
- (2) The State shall tender all plea offers no later than **November 4, 2022**.
- (3) Calendar call will be held on **November 14, 2022**, per the attached calendar. **No negotiated pleas will be accepted after this date.**
- (4) Motions will be heard on **November 18, 2022**.
- (5) Jury selection will commence on **November 28, 2022**.
- (6) Trial will commence on **November 28, 2022 and continue through December 2, 2022.**


