**In Re: CRIMINAL JURY TRIALS FOR ALL PENDING CASES**


The following schedule shall apply to all pending cases on the attached calendar, subject to alteration upon good cause shown by either party and approval by the Court. The Court hereby **ORDERS** the following:

1. Both parties shall exchange discovery no later than November 28, 2022.
2. The State shall tender all plea offers no later than November 28, 2022.
3. Calendar call will be held on December 9, 2022, at 2:00 p.m., pursuant to the attached calendar. When the Court calls the calendar, it expects the parties to make one of the following announcements: (1) ready for trial; (2) not ready for trial, and therefore requesting a continuance from the calendar; or (3) ready for a plea. Without a showing of good cause, the Court will not “pass” a case from making one of these three announcements.
4. Motions will be heard on January 6, 2023, at 9:30 a.m.
5. Jury selection will commence January 9, 2023, at 9:30 a.m.
6. Trials will commence on January 9, 2023, at 9:00 a.m. and shall continue through January 13, 2023.

It is further **ORDERED** that jury selection shall take place in the Jury Assembly Room, Glynn County Courthouse, located at 701 H Street, 2<sup>nd</sup> Floor, Brunswick, Glynn County, Georgia; and jury trials shall take place in Superior Court at the Glynn County Courthouse, Brunswick, Georgia.
