RECREATION & BEACHES

- Recreation activities are made inclusive for persons with disabilities. Staff addresses accommodations on a case by case basis. The following activities make accommodations regularly: **t-ball, baseball, softball, tennis, swimming lessons.**
- **Mobi mats** that provide a firm, stable surface are located at the Coast Guard Station & Massengale Park for access from ADA parking to water's edge.
- **Chair Lifts** are available at Neptune Park Fun Zone & Selden Park Pool to assist patrons needing assistance in and out of pools. In addition, the Fun Zone pool features a **zero entry access pool.**
- **Showers** with handicap accessible stalls are available at Altamaha Park and Neptune Park Fun Zone.
